What are the packaging requirements for lithium batteries?

Packaging Requirements: Use UN-certified containers designed for lithium batteries, often made of non-combustible materials and equipped with safety features like smoke detectors and pressure vents. Ensure proper cushioning to prevent physical damage during transit.

Are lithium batteries a hazardous material?

Effective control of lithium battery transportation is essential to ensure safety and compliance with global shipping regulations. Lithium batteries are classified as Class 9 hazardous materials under the Hazardous Materials Regulations (HMR).

Do lithium batteries need to be labeled?

Except for containerized lithium-ion battery energy storage systems and vehicles powered by lithium batteries (pure electric or hybrid), each package containing lithium batteries must be labeled with the correct shipping name and the corresponding UN number prefixed with the letters "UN.".

What is a Dangerous Goods label for lithium batteries?

Except for containerized lithium-ion battery energy storage systems and vehicles powered by lithium batteries (pure electric or hybrid), packages containing lithium batteries or battery packs must be affixed with the 9A dangerous goods label as shown in Figure 4 or the lithium battery mark as shown in Figure 5, as required.

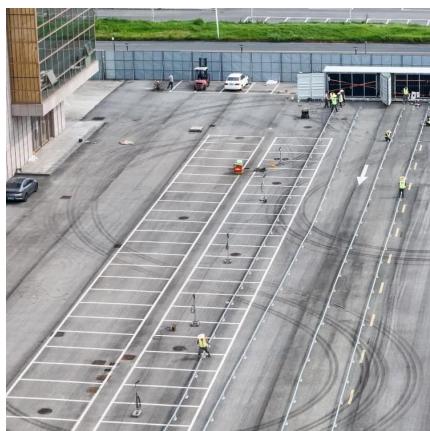


