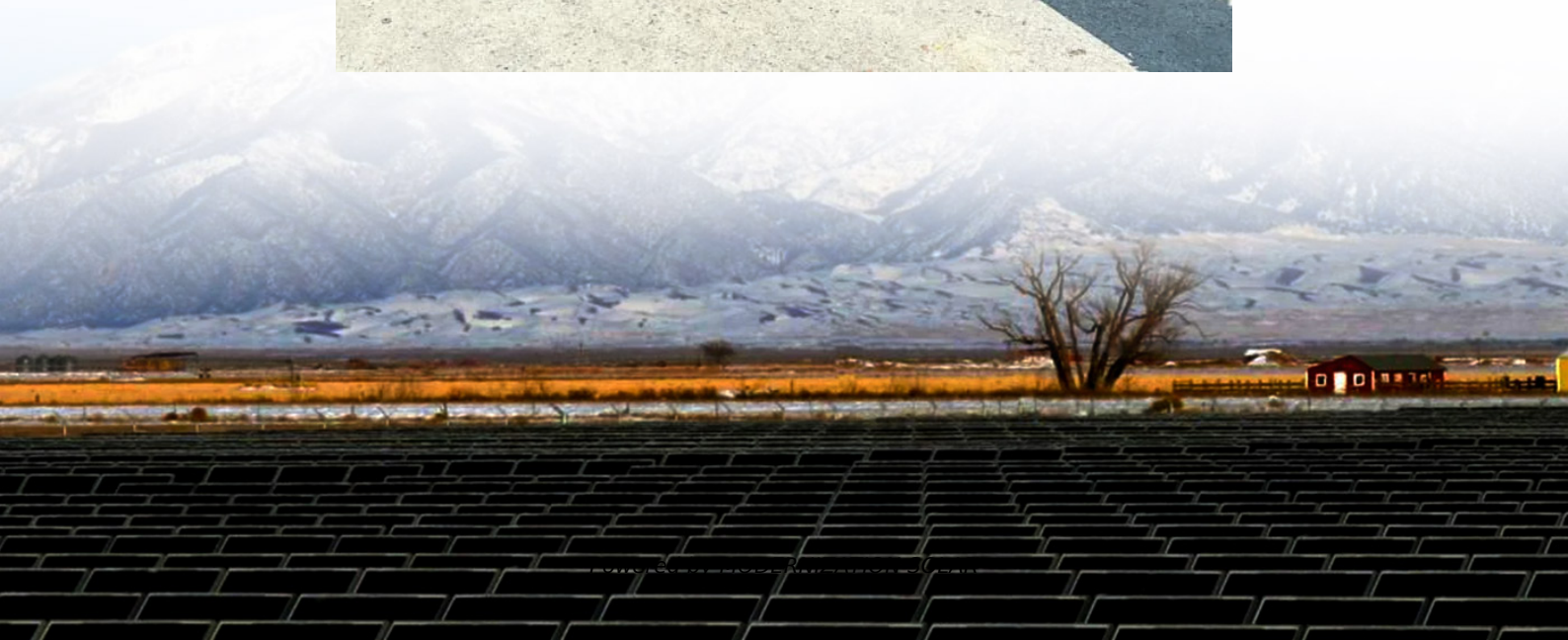


Eastern Europe Backup Power Storage Investment





Overview

Which European markets are the best for battery energy storage systems?

Gresham House and Gore Street have the biggest European BESS portfolios, but Innova, CIP and Enel Green Power have huge project pipelines and could emerge as dominant players. Germany, the UK and Italy are the most attractive markets for battery energy storage system (BESS) investment, according to new research from Rabobank.

Who owns European energy storage assets?

According to Wood Mackenzie data, the top five owners of European energy storage assets as of November 2024, were: 1. Gresham House (Approx. 800MW of energy storage in operation) 2. Gore Street (400MW) 3. Harmony Energy (Approx. 360MW) 4. Uniper (Approx. 355MW) 5. Statera Energy Limited (Approx. 350MW).

Is energy storage a good investment in Europe?

Compared to classic renewables, energy storage has really only become an investable asset in Europe over the last few years on the back of technology advances, market price signals, and government support mechanisms.

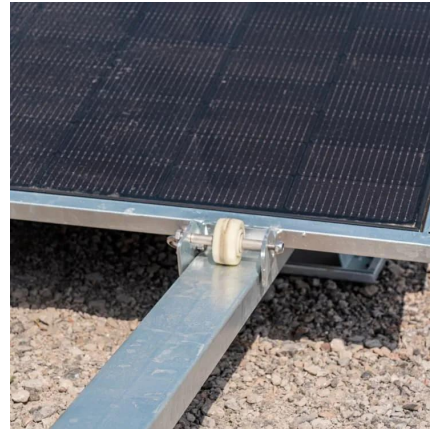

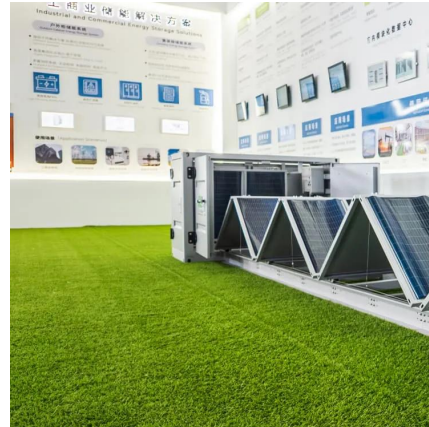

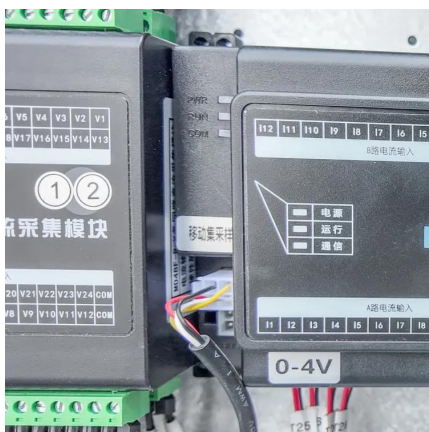
