

# Ireland's Automated Mobile Energy Storage Containerized Project





## Overview

What is the electricity storage policy framework for Ireland?

In line with CAP Action EL/24/16, the Electricity Storage Policy Framework for Ireland (ESPF) was published by my Department in July 2024. The policy framework included 10 Government actions to support the role of electricity storage systems in Ireland's energy transition.

Should 'long duration' electricity storage systems be integrated into Ireland's Electricity Grid?

In this regard, greater emphasis is placed on ensuring 'long duration' electricity storage systems – systems that have the capacity to deliver electricity throughout at least a four-hour period – are integrated into Ireland's electricity grid.

What is Ireland's energy transition policy framework?

The policy framework included 10 Government actions to support the role of electricity storage systems in Ireland's energy transition. Actions #6 to #10 of the policy framework are designed to stimulate the development of the optimum level of electricity storage systems, including Long Duration Electricity Storage on to the grid network by 2040.

What is Ireland doing about battery & storage?

With a recent policy statement, Ireland is seeking to accelerate the growth and integration of battery and other storage systems into Ireland's electricity grid.
