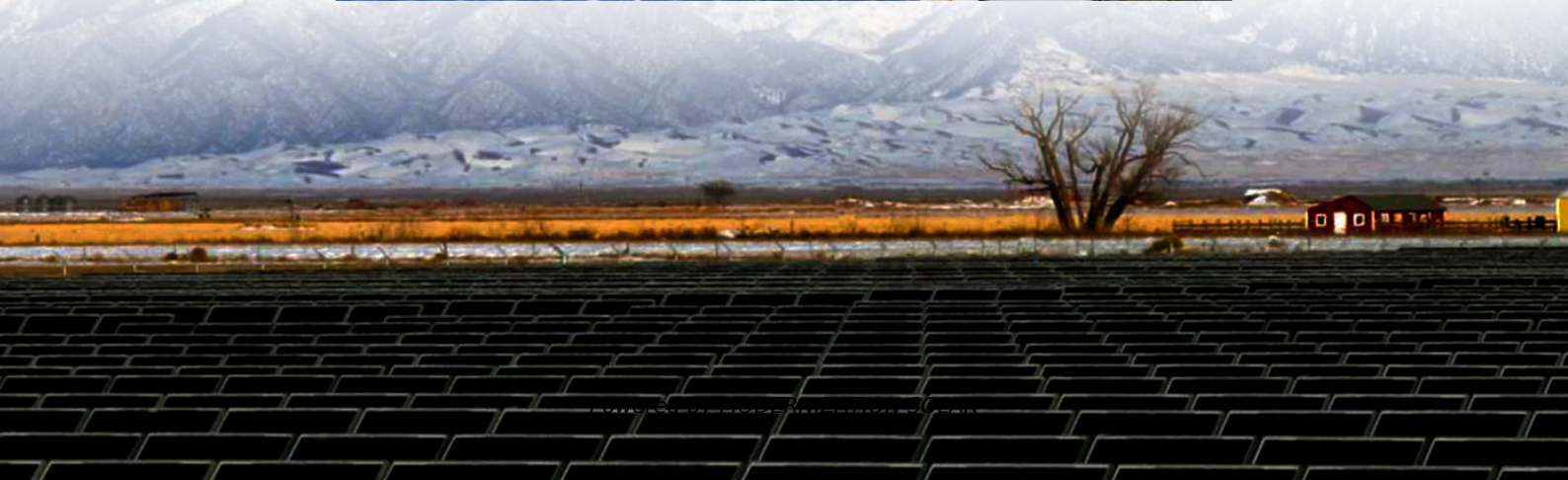


What are the warranty requirements for portable energy storage





Overview

What are the requirements for energy storage systems?

Energy storage systems shall be installed in accordance with NFPA 70. Inverters shall be listed and labeled in accordance with UL 1741 or provided as part of the UL 9540 listing. Systems connected to the utility grid shall use inverters listed for utility interaction.

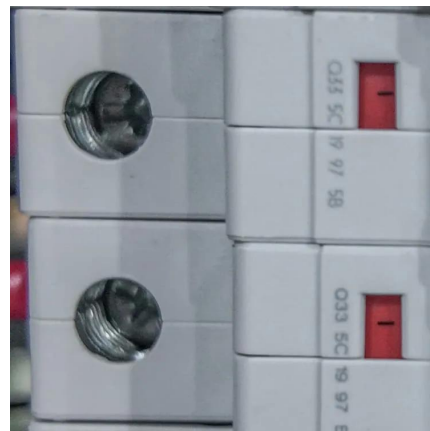

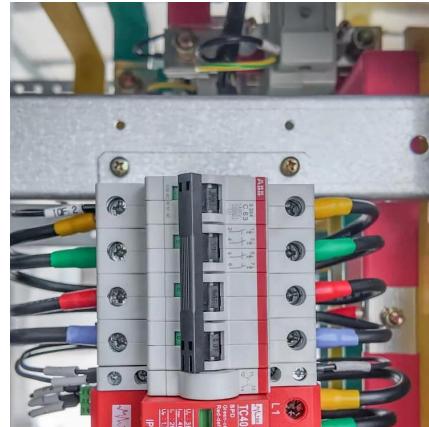
